

# 2022 Barber Honda Round Robin



**Singles & Mixed: Feb. 25-27**  
**Doubles: March 4-6**



**Event Information:**

1. **A ROUND ROBIN format will be used in all draws.** Events with 8 players or less will be complete round robins where you will play against all other players in the draw. Events with draws larger than 8 players will be broken into 2 groups and the 2 group winners will play for 1<sup>st</sup> and 2<sup>nd</sup> place. The entire round robin will be completed in one time slot of 3 to 4 hours. An abbreviated scoring format will be used to complete the draw in the allotted time. You will remain with the partner you enter with in both the Mixed Doubles and Doubles events.
2. **Players must follow social distancing guidelines (provided by tournament director at check in).**
3. **Prizes will be awarded in each division to first and second place.** Final standings will be determined by total number of games won in all matches.
4. **Draws can be viewed on KCTA website ([www.kerntennis.org](http://www.kerntennis.org)).**
5. **You do not have to be a USTA Member to participate.**
6. **Entries must be received by MONDAY Feb. 21<sup>st</sup> by 8:00 pm for SINGLES & MIXED and MONDAY Feb. 28<sup>th</sup> by 8:00 pm for DOUBLES.** Make checks payable to Stockdale Country Club (SCC). Mail or deliver to Robert Limpias, Stockdale Country Club Tennis Shop, 7000 Kane Way, Bakersfield CA 93309. Entry fee must accompany entry form. No refunds will be given once the draw has been made.
7. **All players are responsible for knowing their time of play and are expected to be able to remain on site for the full duration of the estimated 3 to 4 hour Round Robin.**
8. **A 15-minute default rule will be strictly enforced.**
